## ***Super Stripping Approved Aircraft Paint Stripper Non-Phenolic, Neutral***

### **DESCRIPTION**

CH4849 is a powerful, neutral type, non-phenolic paint stripper for application by brush or spray onto aircraft surfaces.

### **CHARACTERISTICS**

CH4849 is a non-phenolic, fast acting stripper. CH4849 is a heavy bodied, ammoniated, clear viscous material which will cling to vertical and inverted surfaces. CH4849 is non-corrosive and does not cause hydrogen embrittlement to aluminium, cadmium, high strength steel and all aircraft metal surfaces.

### **APPLICATION**

**Precautions** - CH4849 is damaging to acrylics, most plastics and composites. Avoid contact to prevent damage. Clean any soiled or oily surfaces prior to stripping. Mask off all perspex, plastic or rubber components. To avoid unnecessary evaporation, carry out stripping operation away from direct sunlight or wind.

Apply CH4849 by spray or brush. For spraying use a President Hydra-Clean pump or equivalent. Once paint film has blistered, brush if necessary, and then rinse off with high pressure water, or scrape and rinse off with water.

As the stripper contains wax it is important to clean the surface firstly with an approved aircraft degreaser CH511C, CH087 or CH303MIL.
